A. President (Michael Clark)

B. Vice President (Cyndi Gomez)

Picture Update- Cyndi need the Rec coaches' names and addresses for the free team photo that the photographer would like to send to the coaches. Rec's photos are done except the U12 team that did not show up or contact anyone. The access link to order the photos will be sent out in a blast email to everyone.

Light Update- Salt and Light gave us a quote of \$12,000 to replace bulbs and repair if needed for the field lights. We are working on a different option for us to rent a lift and purchase the lights ourselves to replace. Dustin (Cathy's son) is going to see if he can organize this for a better price. We need to mainly focus of Fields 5 &4 because they are almost completely dark.

C. Treasurer (Cathy Jones & Mike Clark)

Checking: \$53,659.82 Saving: \$1.119.00

We have about \$14,357 in outstanding checks.

We own about \$5.600 for player fees but Jennifer needs to confirm because Super 2 was included on this invoice. We also need to check on WDDOA fees for an update. Cyndi said that she would check on this.

We have about \$70,000 in trainer fees remaining for 2020-2021 season.

## E. Facilities Commissioner (John Cody)

We are going to hold off on aeration and planting the rye seeds until we can see if it will get cold enough for the seeds to germinate. Fields will be closed the first weekend of Dec. We are working on a plan to repair the lights on field 4& 5
