A. President (Michael Clark)

E. Facilities Commissioner (John Cody)

- John is working to keep the fields up the best he can and they really look good. John would like to spread rye seed after the end of the season to help maintain the fields through the winter. He is going to price the cost of the seed and let us know what it will take. He will need help with aerating before spreading the seed, but will let us know the dates as it gets closers. The end of the season is 11/21.
- John and Mike are also working on plans for a new storage shed to help house the equipment. John may possibly apply for a grant for the cost of the shed.
- Golf Cart may have a wiring issue but Mike and John are looking into this when they can.
- The big mower now has a new seat, but needs other repairs at this time.

For the Academy Hosting Block Schedule,
