1) Call to Order/Attendance: 7:02 pm

- 2) Secretary (Carmen Sifuentes):
 - a) 2 volunteers to review minutes: Cathy, Erica V
 - b) Sign Up Genius Reports: Technical Trainings, Goalie Trainings: C will send reports to JP to send to managers
 - i) Cathy proposes paying a separate goalie trainer for the goalie trainings

3) President (John Cody)

- a) SLE Light Proposals: Last meeting we ended with questions about priority of what we need and how to pay; \$7,720 bid was most critical; Monthly payment is \$117; If we pay off within 90 days, there is no interest even if we finance through them this job repairs the controls and fuses which is what we keep having issues with; 2nd part was to replace light fixtures, \$ 21,645; \$329.01 monthly
- b) John will find out how long the 21k job will take and when they can start;
- c) Carmen makes a motion that we spend the \$7k for SLE to fix the lights; Satch 2nds; no one opposed; passes unanimously;
- d) Will STYSA allow us to use grants to pay off debt we take on to fix lights?

- a) Financial Report: Did an income and expense forecast through the next season to project how much money we might get for things we are discussing that we need; Financial Report submitted to Carmen;

- g) Revisit Turf Field/Improvement Project: Roy is looking for money for turf; For Field 1 as a multi function field; Roy can share the figures for this project
